Each bid shall contain the full name and address of each person or company submitting the bid. All bids must be submitted to the Belmont County Board of Elections 52180 National Rd. Box 994, St. Clairsville, Ohio NO LATER THAN August 19, 2019 AT 1:00P.M.

Bids will be opened by the Director in public session on August 19, 2019 at approximately 4:00P.M. at the Board of Elections office 52180 National Rd. Box 994 St. Clairsville, Ohio 43950. Bids shall be clearly marked on the outside of the envelope in the lower left-hand corner as "BID ENCLOSED". The name and address of the bidder must also appear on the outside of the envelope.

Each bid must be accompanied by two sureties, or a surety's company satisfactory to the Board, in a sum double the amount of the bid, conditioned upon the faithful performance of the contract for such printing as is awarded and for the payment as damages by such bidder to the Board of Elections of any excess of cost over the bid which may be obliged to pay for such work by reason of the failure of the bidder to complete the contract. FAILURE TO SUBMIT A PROPER BID WILL AUTOMATICALLY INVALIDATE THE

BID. Bid guarantees of unsuccessful bidders will be returned following award of bid.
